Golshani Literary Group AS

Golshani Literary Group AS is a Norwegian creative arts company and literary project based in Grimstad, Norway. The company's work brings together original literature, philosophical and psychological inquiry, visual expression, and digital art.

Golshani Literary Group presents and sells original literary works through its own digital platform. It is not a traditional publishing house and should not be described as a company that provides publishing services.

The company is registered under organisation number 937 308 868. Its official industry classification is 90.120 – Visual arts creation activities, and its registered activity includes the production of digital art.

History

Golshani Literary Group AS was established on 16 February 2026 and registered in the Norwegian Register of Business Enterprises on 6 March 2026. The company was founded by Mona Golshani as a legal and creative framework for her literary, artistic, and digital work.

The company's statutory purpose covers literary activity, including the creation, sale, and distribution of books and digital products, together with investment and related activities. This statutory wording does not mean that the company operates as a conventional publishing house.

Creative and Literary Work

Golshani Literary Group is centred on original works by Mona Golshani. The works combine elements of psychology, philosophy, autobiography, mysticism, mythology, political psychology, and symbolic storytelling.

The literary work explores themes including:

identity and belonging

power, influence, and control

human behaviour

culture and memory

internal and external conflict

truth and perception

silence and self-definition

mysticism, symbolism, and mythology

A recurring focus is the way visible and invisible structures influence human thought, behaviour, relationships, and decision-making. The works examine how language, memory, culture, authority, and emotional pressure can shape a person's understanding of themselves and the world around them.

Visual and Digital Art

In addition to its literary work, Golshani Literary Group is involved in digital and visual artistic activity. The company's official Norwegian industry

classification is visual arts creation activities, while its registered business activity is described as the production of digital art.

Visual presentation, symbolic imagery, atmosphere, and digital design form part of the company's broader creative identity. These elements are used to support the themes and emotional environments presented in the literary works.

The Works

Golshani Literary Group presents a collection of original works across psychological, philosophical, autobiographical, mystical, and mythic genres. Its website describes the collection as an archive of works rather than as a conventional publishing catalogue.

Common Ground

Common Ground brings together works concerning culture, community, identity, belonging, control, and the hidden systems that influence human life.

The works are based partly on lived experience but are presented as reflective cultural works rather than memoirs in a narrow or conventional sense. They examine how traditions, inherited expectations, social pressure, and authority influence identity and human relationships.

To Enjoy Life

To Enjoy Life explores manipulation, control, emotional influence, truth, and the process of regaining personal clarity.

The work examines forms of control that may operate quietly by influencing perception, judgement, and self-understanding. Its focus is not only on recognising external influence, but also on recovering an independent sense of truth and personal direction. ([Golshani Group][3])

Mona Golshani is the writer and creative figure behind Golshani Literary Group. Her work combines psychological, philosophical, mystical, autobiographical, mythological, and political themes.

Her writing is particularly concerned with power, silence, identity, culture, memory, internal conflict, human influence, and self-definition.

Digital Platform

The company's website serves as a digital presentation space, archive, and online store for its original works. Visitors can explore the themes behind the works and purchase selected titles in digital form.

The website currently offers e-books that can be accessed and read on compatible phones, tablets, and computers. The digital platform allows Golshani Literary Group to present literature, visual material, and artistic concepts within a unified creative environment.
